



Mr. Towers –

Per your (supplemental) request for Recreational League status for (the recreational “division”) your league: B3XNF, I have reviewed the submitted league rules etc.

Determination:

Your League’s “Recreational League” component is **APPROVED** as a Recreational League, per FYSA guidelines and as such, teams participating in this league may register players as Recreational players with FYSA.

This approval is based on the following stipulations:

- 1) The Recreational designation **ONLY** applies to your Recreational “Division”, **NOT** to any select or competitive components of your overall league.
- 2) This designation applies for teams which are in compliance with your Recreational rule requirements – as submitted 1/29/2011, based on your Board of Directors meeting decision from the November 2010 meeting.
- 3) Teams which participate in a non-recreational league or division in addition to this league – will be considered as “competitive”.
- 4) This designation is applicable as long as the rules upon which it was granted are in effect and are not changed.
- 5) Please consider amending your league by-laws (if you have not already made provisions to do so) to include the required language pertaining to formation of recreational teams (Per USYSA Policy for **Players** section 101 – B16 or B17).
- 6) This determination may be removed if it is found that this provision is removed or is not enforced.
