I would recommend to everyone who is having higher levels games to contact Chris to get academy level referees for your games. FSL, all the upper level advanced teams.

Every one should be working to have grade 7 above doing centers on advanced games above U15 level.

Using solid AR is the way to work these games.

Also, Please make sure that all referees know the water FYSA policy - attached for you.

Key: U12 below are a must for water breaks at any games played under FYSA.

All reports for misconduct RED CARDS - etc. which are played under FYSA rules must be reported on a **FYSA game report**. Copy of both teams roster are attached to report. The only time a USSF report is used is for referee assault/abuse reports and this is the only time player passes will be kept and sent in with the report. All reports should be sent in within 24 hours of the incident to the proper authority.

Questions please contact me.

I plan to stop by some of the field in the next few weeks and take a look at the referees. If you have someone that I should be assessing let me know.

Upgrade classes for grade 7 & 6 will be held in area B in the next few months any referees needing upgrade must attend one of these classes.
